WHAT IS POLICE EXPLORING?

Police Exploring is a program (consisting of young men and woman ages 14 to 20) sponsored by your local law enforcement agency and a division of the Boy Scouts of America; Learning for Life Program. It is a great opportunity for youth to experience a possible career in Law Enforcement, learn more about their community and the importance of their contribution in their activities.

WHO CAN BE A POLICE EXPLORER?

- Age minimum of 14 years old and completion of the 8th grade.

REQUIREMENTS

- Parental approval, including general liability release
- Enrolled as a full time student in a public or private school (includes home schooling) .
College students are allowed up to the age of 21 years old
- Maintain a "C" average or better.
- NO disqualifying criminal record.
- Pass an interview with a panel of Police Explorers Advisors

WHAT'S IN IT FOR ME?

Law Enforcement Exploring provides educational training programs for young adults on the purpose, mission and objectives of law enforcement. The program provides career orientation experiences, leadership opportunities and community service activities. Primary goals of the program are to help young adults choose a career path within law enforcement and to challenge them to become responsible citizens of their communities and nation.
