

RESOLUTION NO. 1377

**A RESOLUTION ESTABLISHING FEES FOR SERVICES
PROVIDED BY THE CITY OF TOLEDO AND
REPEALING RESOLUTION NO. 1358**

WHEREAS, the City of Toledo provides a variety of services to the public; and

WHEREAS, cities commonly charge fees for some services to help defray the costs of providing those services; and


WHEREAS, the city's fees have been reviewed by staff who considered costs of providing services and fee schedules from other communities.

NOW, THEREFORE, BE IT RESOLVED:

- Section 1. The fee schedule attached as Exhibit A is adopted.
- Section 2. The fees established by Exhibit A of this resolution take precedence over the same fees which were previously adopted by resolution or administrative policy.
- Section 3. The City Manager shall review the fees annually on or about May 1st and shall modify the fees based on the cost of providing the services. A report on the fee schedule will be prepared and presented to the City Council at their first regular meeting in June of each year.
- Section 4. This resolution shall be effective on July 1, 2016.
- Section 5. This resolution repeals Resolution No. 1358 in its entirety as well as all previous years' fee schedules.


